## **Boral appoints two new independent non-executive Directors**

Boral Limited (ASX: BLD) today announced the appointment of Mark Johnson and Jacqueline Chow as independent non-executive Directors to the Board. Mr Johnson's appointment is effective immediately, and Ms Chow's appointment is effective 1 March 2022.

These appointments are consistent with Boral's previously announced renewal plan to recruit two new independent Directors.

#### Mark Johnson

Mark Johnson is an experienced non-executive Director and currently serves as Chairman of The Hospitals Contribution Fund of Australia Ltd (HCF) and is an independent Director of Goodman Group. He was until recently Chairman and a Director of G8 Education Limited and was formerly an independent Director of Coca-Cola Amatil Limited and Westfield Corporation Limited. He is also a director of Aurecon Limited and The Smith Family, an independent member of the Board of Corrs Chambers Westgarth and a Councillor at UNSW Sydney.

He previously held several senior leadership roles during his more than 20 years as a senior partner at PricewaterhouseCoopers ("PwC"), including as CEO of PwC Australia from 2008 to 2012, and positions as Deputy Chairman PwC Asia and member of PwC's Global Strategy Council.
